We had two spectacular concerts that went really well. All three bands are going to festival this year. April 22 symphonic band, April 29 wind ensemble and concert band is going to a festival hosted by Del Mar on May 6.

Marching band meeting Wednesday, April 12. The schedule for the Fall season will be out early and there will be some changes. For the month of August we will have Friday rehearsals. The schedule will lighten up in November.

Auditions for Wind Ensemble, Symphonic Band and Jazz 1 the second week of May. Audition material released the week of second week of April so they will have a month to practice. There are 100 hundred students signed up for Wind Ensemble. I have 30 signed up for Jazz and that doesn't include the 15 that will sign up as an activity so I will split it into two again. A lot more donations have come in for choir. Choir is going to Disneyland Memorial Day weekend.

IX. Treasury Report

Each of the programs are coming in on budget. The last two concerts brought in \$1463, which is down a little bit. We usually see about a \$1,000 a concert. Right now we have brought in more than we have spent by \$26. We still have a few concerts that will bring in more money. Marching band has about a \$6,000 carry over for next year. Matching gifts continue to trickle in.

Winter Percussion and Winter Guard are both on track to break even. Hopefully donations will continue to come in so we can pay it forward to next season.

Unrestricted funds for this year came to \$48,000 and all of that has been divvied up and we have spent \$32,000.

X. Communications

XI. Operations
