THIS GROUP REQUIRES UNIFORMS, PERFORMANCE RIGHTS TO MUSIC, TRANSPORTATION TO AND FROM COMPETITIONS, LODGINGS, MEALS AT COMPETITIONS, MANPOWER TO HELP MOVE INSTRUMENTS AND PROPS, THE PURCHASE OF SMALL PROPS, FUNDING FOR OUTSIDE TECHNICAL COACHES AND SHOW DESIGN, AS WELL AS OTHER VARIOUS EXPENSES.
